# CALL FOR APPLICATION TO ATTEND THE TRAINING WORKSHOP ON NEW INCOME TAX LAW No 027/2022 of 20/10/2022 ESTABLISHED TAXES ON INCOME

Imanzi Business Institute is inviting all companies, consultants and other interested people to apply for the professional course on the newly enacted Income Tax Law No 027/2022 of 20/10/2022 establishing taxes on both personal and corporate taxes on income. The training will provide updated and hands-on skills to entrepreneurs and is aimed at strengthening and consolidating the fundamental and/or specialized tax knowledge of participants so that they may perform their functions effectively and efficiently.

## **Introduction**

The Government of Rwanda provides a variety of services to the people they serve and in order to pay for these services, the government imposes taxes on the citizens and companies who generally enjoy the benefit accruing from these services. Further, the government must also make payments on any commitments made and loans received in previous years to finance past operations.

Since 2005, the income tax legislation of Rwanda has been governed by two important tax laws. First, Law N°016/2005 of 18/08/2005 on direct taxes on income and Law N°016/2018 of 13/04/2018 establishing taxes on income. Nevertheless, due to various challenges raised by the taxpayers and other users of the law, a couple of reforms were proposed to amend the Income Tax Law which was then enacted to enhance tax compliance and boost private sector investments.

On 28 October 2022, Rwanda's new income tax law came into effect, replacing the previous law <u>no. 016 / 2018 of 13/04/2018</u>. The new tax law reflects significant changes to the Rwandan income tax system as it introduces important alterations.


Some of the major changes introduced in the new law are related to the Tax treatment of partnerships, thin capitalization, taxation of gambling companies, residence for individuals, withholding Taxes, exemption of low-income employees up to 60,000 RWF and the general anti-avoidance tax provision to name a few.

### Purpose of the Training

The purpose of this workshop is to enable the PSF members to comply with the new Income Tax law in place, and to comprehend basic expressions in taxation. Therefore, all basic terms will be defined and explicitly explained as well as suitable illustrations will be provided that defines their meaning and scope in the Rwandan Context.

The overarching objective of the training is to build tax resilience to help improve compliance skills in taxpayers. Specifically, the training aims to:

- Train and build capacity in taxation, to improve the level of compliance of PSF members in addressing tax issues such as related tax computation, declarations, tax accounting management and compliance in general, according to the new Income tax law.
- 2. Integrate and apply knowledge gained from the workshop on tax issues in institutionalized settings, in a culturally sensitive way to tax compliance in policy and practice.
- 3. Develop a model of training related to tax, which can be further perpetuated.







## **Training Contents to be covered:**

The training on Income tax will cover the following areas of interest to business community:

- 1. The main changes in the new Income Tax Law
- 2. Different definitions in new Income tax law
- 3. Income-tax rates
- 4. Tax assessment and early interventions
- 5. Requirements to improving compliance level under the new income tax law

# **Training Outcomes**

The course will cover a wide range of topics as illustrated above resulting in participants to:

- 1. Understand new provisions in the law and the negative implications such as penalties, interests and fees for non-tax compliance, etc.
- 2. Boost compliance level of PSF members and other business operators.

## **Mode of Training Delivery**

The training will be conducted face-to-face for four days. Materials for the training will be in English (presentations), but Kinyarwanda with practical examples will also be used for explanations. In addition, materials that will be used during the presentation shall be shared after the training. Further, provisions summarizing the income law will be published and accessible by all PSF members for future use. Participants are expected to actively engage in all training activities.


#### Training material
